

Guidelines

How to prepare your paper for *Lingua Aegyptia*

Authors are asked to follow the *LingAeg* style when preparing a manuscript. If you submit a manuscript that does not follow our style you will be asked to apply these guidelines before submitting your final version if the editors decide to accept your paper.

1 Abstract, format & presentation

- Each article should contain an English abstract. It should begin with an English translation of the article’s title if the article itself is not in English.
- The first footnote (‘1’)¹ follows the author’s name and contains his or her location/affiliation and email address. You may add acknowledgements here.
- Please use the provided Word-template. It includes a placeholder text, the type area and the most important styles for headings and paragraphs.
- Please do NOT use the automatic numbering of MS Word (for paragraphs/sections or examples).
- Please do NOT use the automatic bulleted or numbered lists offered by MS Word. The template contains paragraph styles to be used for lists (paragraph style ‘LingAeg_Ex (list)_1-first’ etc., see the dot-file for an example).
- When adjusting the transliteration, the glossing and the translation of an example please use tabs (instead of spaces) or tables. The paragraph styles ‘LingAeg_Ex (Nr)_1-first’ and ‘LingAeg_Ex (Nr)_2-middle’ are already containing tab settings. The Word-template does also contain tables you might use.
- Please use an en dash (–) in ranges (e.g. 1928–1935), and around parenthetical expressions – such as this one – with a single space on each side.

2 Fonts

- Please use “Times New Roman” (not “Times”) for the main text and the footnotes.

1 Other footnote styles (e.g. ‘*’) are not allowed.

- “[Umschrift TTn](#)” (please use the latest version 3.0) or “[Transliteration](#)” are recommended as transliteration font.
- For Coptic “[Antinoou](#)” is recommended.
- All other fonts have to be sent together with the manuscript.
- **Bold face** should be avoided whenever possible, please use *italics* instead (for emphasis etc.).

3 Glossing & hieroglyphs

Authors are kindly asked to present their examples not only by giving a transliteration and a translation but also by providing glossing lines. You are also welcome to add a line of hieroglyphs.

3.1 Glossing

You are asked to familiarize yourself with the following resources:

- The article “[Glossing Ancient Egyptian. Suggestions for adapting the Leipzig Glossing Rules](#)” by Camilla Di-Biase-Dyson, Frank Kammerzell & Daniel A. Werning (in the appendix of *Lingua Aegyptia* 17).
- The collaborative online Wiki [Glossing Ancient Languages and Texts](#).

The Word-template contains examples for both options: using tabs and using tables to present examples. Please choose one of them.

3.2 Hieroglyphs

You may submit hieroglyphs generated by [JSesh](#). If you do so please use the following preferences for the clipboard settings (Zwischenablage-Einstellungen):

- 11 pt (for main text line), or 9 pt (for footnote line)
- Clipboard format: WMF
- In Word you may lower the hieroglyphs by 2pt or 3pt (select the hieroglyphs and adjust the font settings: ‘font’ > ‘character spacing’)

4 Supra references

Supra references (loc. cit., op. cit., idem, ibidem etc.) should be avoided. Cross references to the article's pages are not accepted. Please refer only to paragraphs or chapters. If you like to refer to a footnote please highlight this cross reference (“See **fn. 15.**”).

5 Quotation marks and brackets

The style of quotation marks corresponds to the article's language (*not* to the language of the quotation):

English	“Text ‘within’ quotation marks”
French	« Text ‘within’ quotation marks »
German	„Text ,within‘ quotation marks“

Square brackets should be used when brackets are nested (i.e. please use square brackets [like these] inside round brackets):

“Roeder (2009: 104–105 [n. 114])” or “(Roeder 2009: 104–105 [n. 114])”

In quotations, points indicating an ellipsis (i.e. the omission of a portion of the text) should be enclosed within square brackets: [...].

6 Tables and illustrations

6.1 Tables

A table's heading is placed above the table. Please avoid vertical lines. If in doubt, align left. Footnotes in tables should be avoided. Please use an own numbering instead as indicated in the Word-template (a, b, c...).

6.2 Illustrations

- Illustrations have to be submitted as separate files (TIFF, JPG, PDF etc.).
- There are requirements to be met regarding the illustrations' resolution:
 - grey scale illustrations: 300 ppi (or higher)
 - line drawings: 800 ppi (or higher)
- Diagrams from PowerPoint are usually not suitable for printing. If you like to use such an illustration please submit not only the illustration file itself but also the PowerPoint file.

7 Bibliographic style

Authors are asked to follow the author-year system and to add a bibliography. For those book reviews and miscellanies which contain only very few bibliographic references it might be sufficient to give the full bibliographic references in the footnotes without adding a bibliography (see 7.3).

7.1 Examples for citation styles within the footnotes or the main text:

7.2.4 Defining abbreviations in the bibliography

- LEM* *LEM* = Gardiner, Alan H. 1937. *Late-Egyptian Miscellanies*, Bibliotheca Aegyptiaca 7, Bruxelles.

NB:

- (1) Abbreviations of frequently cited works (e.g. *Edfou* II, EG, *Urk.* IV) have to be defined in the bibliography or in a separate list of abbreviated literature (cf. 7.2.4).
- (2) Titles of series have to be given in full. Common abbreviations of journals (*JEA*), series (PdÄ), and lexica (*LÄ*) are *not accepted*.
- (3) The same applies to first names.
- (4) In the bibliography the surname precedes the first name only in the initial position of a bibliographic entry:

Festschrift für Günter Burkard*, Ägypten und Altes Testament 76, Wiesbaden, 21–26.
- (6) Within bibliographic items, the use of *italics* is restricted to titles (and subtitles) of monographs, edited volumes and journals.
- (5) The usage of full points, commas and ampersands should be consistent:

Full points are used as separators on both sides of the year, before a subtitle (if no colon ':' is used) and at the end of the entry:

Otherwise `c o m m a s` are used as separators: after the initial surname of the author, in lists (of authors, editors, places), after the title of articles, monographs, edited volumes, series and journals and also after places:

`c o l o n s` are used with “in” introducing journals or edited volumes (and before the publisher if you decide to mention publishers²). It may appear before the subtitle (if no full point is used):

The `a m p e r s a n d (&)` is used in lists of authors, editors, places etc.:

2 If you decide to mention publishers you have to do this consistently and throughout the whole bibliography.

- (5) Quotation marks are only used if there are part of a title. They are not placed around titles:

Burkard, Günter. 1999. «Als Gott erschienen spricht er». Die Lehre des Amenemhet als postumes Vermächtnis, in: Jan Assmann & Elke Blumenthal (eds), *Literatur und Politik im pharaonischen und ptolemäischen Ägypten*, Bibliothèque d'Étude 127, Cairo, 153–173.

- (6) The language style within bibliography follows the article's language (and not the bibliographic item's language):

[Within a bibliography of an English article:]

7.3 Examples for full references in the footnotes

Checklist

Before submitting articles for *Lingua Aegyptia*

Please check the following list (cf. the given chapters of the guidelines for further information):

- English abstract included? (cf. § 1)
- Is the manuscript anonymous? (cf. § 8)
- Is the en dash (–) used? Please check bibliographic references and items. (cf. § 1)
- NO automatic numbering (examples, chapters etc.) used? (cf. § 1)
- NO footnotes used within tables? (cf. § 6.1)
- Has the citation/bibliographic style been applied? (cf. § 7)
- Did you compile a PDF file for the submission? (And please provide special fonts if used.)
